Me and my brother went to Egypt abroad on August 9, 2016 to receive higher education with the advice of our parents. Two months after we went to Egypt, my father (Mutellif Abduvayit) was put into prison by the Chinese government under the name of training camps, where he was tortured and persecuted. They tortured him so severely that our neighbor who work in the prison can not even recognize him .After our neighbor's son told us that a few months was very difficult for us psychological. A month after my father was arrested, my 28 years old brother (Mihirbulla Wubulikasimu) was also arrested. When I learned that they didn't even tell me where they were taken, I bought tickets to return to the country, but my close-friend called me back and pleased me about not coming back.She told me if I would come back I risk my life.She cried,

begged me not to go back, saying that I would encounter the same things, and I had to cancel the ticket. From this date don't have contact with any member of my family. While we were going to our university in such a difficult situation in May 2017, the Chinese government and the Egyptian government signed an agreement to return all the Uyghur people to China, the Egyptian police arrested the Uyghurs in their homes and handed them over to China. therefore we borrow some money and fled to Germany. Without money we went to Germany under difficult circumstances. Both of us were still young and not having enough experience for the survive in this difficult situation. We could not overcome the psychological distress, even though the financial problems were somehow passed. We could not overcome the psychological distress because my Eltern and my brother all my siblings (4 girls 3 boys) between four and fifteen years old don't now how to overcome this persecution. My brother's 3 children , three to seven years old, living fatherless. Since my father was imprisoned in June 2017, there had been no news of his crime or where he was or not. In June 2017 we learned that my father was sentenced to 12 years in prison, but we have no idea where my older brother was.

On December 2017, my younger brother (Abdiveli), still 15 years old the fourth child of our family was taken unlawfully to the police station, and during the day, police were forced to do things such as carry liquor bottles, discard rubbish and do housekeeping. He is not allowed to sleep even at night. In January 2018, I learned that the police had entered the house at night and that my fifteen year-old brother had been taken away. Now we don't have where My older brother and my little brother are. I don't have any news about my sisters because I can not call them. After I was exposed to such sad events, my psychology began to deteriorate. I was afraid that they would be tortured every day.

According to a report I received two months ago, my 15-year-old brother Abdiveli, who was arrested, was imprisoned and tortured very much. I learned that he had not taken anything and had gone through three different operations and that the doctors had been taken by the Chinese police despite being told they were at risk of death and that no one was told about her condition. I cannot bear this suffering anymore he is

just 15 years old . We are living in 21st century but we are experiencing the incredible problems that human beings cannot. I don't know how my father bear this he had heart disease. My father was a merchant. He was a very decent person who struggled to have a good life and raise us as a good person. My brothers and my father are innocent people. They have the right to be happy in life like all the people, but they are not. They are under the torment of torture. The Chinese government is making my parents and brothers and all the Relatives in their country the victims of their politics. They take their lives, youths and their childhoods away. I want my parents and siblings I want their happiness, I want them to be free to have their personal rights. I want justice. I want to meet them as soon as possible I want them to have a normal life as we did in the past. I'm thinking my parents and brothers and sisters my days are hurting my heart because my family is under torture and suffering. I have only one wish to have a normal life with my family like old days. The Chinese government, which is the enemy of human life, have taken even the most basic rights of the people, trying to annihilate all People in every respect.

Please help me please I want to meet my family again . Can t my brothers sheltered in the world where millions of people sheltered. please save my parents my brothers and sisters from this persecution. For the sake of humanity , for the sake of social state I want your help.
